Nomination Procedures for Eleventh Class

In mid-April of 1999, Merrill R. Francis, Chair of the Board of Regents, will write to each Fellow requesting that nominations, together with biographical information

and other supporting data, be forwarded to each Circuit Admissions Council by May 30, 1999. Fellows are reminded that the nominations should be complete and that substantial due diligence is required in order to make it likely that a candidate will receive an invitation; incomplete and insubstantial nominations are less likely to receive favorable consideration. Nominations for Judges should be forwarded to Leonard H. Gilbert, (Chair, Judicial Nominating Committee), and nominations for Foreign Fellows should be forwarded to Daniel M. Glosband (Chair, Foreign Fellows Nominating Committee). Thereafter, each Circuit Admissions Council will review nominations received for that Circuit (other than Judges and Foreign Fellows) and begin the process of making recommendations to the Board of Regents. Each Fellow within a Circuit will receive the names of the proposed Fellows (other than Judges and Foreign Fellows in that Circuit) and be asked to comment on each proposed Fellow. Final Circuit Admissions Council recommendations will be forwarded to the Board of Regents, which will meet Wednesday, October 6, 1999, in San Francisco in conjunction with the meeting of the National Conference of Bankruptcy Judges. Invitations to new Fellows for the Class of 2000 will be sent out in mid-November of 1999. 👚

Nonmination Procedures for Judicial Fellows

Over the past several years the number of names submitted to the Judicial Nominating Committee in any one year has been inconsistent, ranging from two to over twenty.

This has somewhat frustrated our quest to find well-qualified candidates. Next year we hope that three elements will coalesce to bring forth additional nominations: growing membership interest, the Committee's review of judicial membership nationwide and the recent change in the bylaws of the College.

The bylaws, as recently adopted, now provide that a member may nominate a judicial candidate from the member's district (previously not allowed) but may not vote on that candidate. The candidate must be licensed to practice law in the highest court of any state for not less than fifteen years and the principal activity of practice must have been primarily in the area of bankruptcy law for a period of substantially all of the prior ten years. Additionally, the candidate must have been a bankruptcy judge for at least five yers and must meet all of the other qualifications for membership required of a non-judicial candidate. Finally, a nomination form must be completed and timely submitted to the Chair of the Judicial Nominating Committee— a letter or telephone call will not suffice.

The Committee recognizes that there are a number of excellent judges throughout the country who should be considered. Accordingly, the Committee has conducted a review of the *Judicial Almanac* in an effort to begin to identify those persons and seek out their nominations in accordance with the process established in the bylaws.

The selection process is quite intense and very time consuming. Once a candidate has been identifed, one or more of the Committee members undertakes a thorough investigation, contacting persons in the area having actual knowledge of the candidate, seeking out confidential evaluations. The texture of the Class of 1999 will be s i g n i f i c a n t l y enhanced by the addition of four distinguished Foreign Fellows. Under the

final year of John Barrett's chairmanship, the selection committee of Grant Newton, Jay Westbrook, Lewis Kruger, Bruce Leonard, Richard Gitlin, Gerry Smith, Peter Totty and Dan Glosband conducted several conference call meetings and exchanges of correspondence to collect nominations, perform due diligence and recommend candidates to the Board of Regents. Distillation of an initial list of 16 suggestions resulted in the four nominees accepted by the Regents.

Each new Fellow comes cloaked in impressive credentials. Gary Colter is from Toronto, is Vice-Chairman of KPMG and has served as financial advisor to the debtor or major creditors in virtually every major recent Canadian restructuring. He was a founding Director of the Insolvency Institute of Canada, is past President of the Canadian Insolvency Practitioners Association, a Director of INSOL International and Chairman of the Canadian government appointed Advisory Committee on Insolvency Legislation that led to recent reforms in Canadian insolvency law.

Neil Cooper of Buchler Philips in London is equally dazzling. He is a prolific speaker and author on insolvency matters, is the President elect of INSOL International and was its primary representative to the UNCITRAL Working Group on the Model Law on Cross-Border Insolvency. He has acted as Trustee, Receiver or Provisional Liquidator in numerous UK, African and Asian insolvencies.

From Western Europe, Dr. Hans-Jochem Luer is one of Germany's leading insolvency lawyers. A partner in Heuking Kuhn Luer Heussen Wojtek in Cologne, he has been chairman of the Insolvency Committee of the German Bar Association since 1990 and recently finished his term as Co-chairman of the Creditors Rights and Insolvency Subcommittee of the International Bar Association. He has published numerous articles in German and English in addition to his active representation of debtors, liquidators and trustees in domestic and international insolvency matters.

Finally, but only alphabetically, Shozo Miyake of Miyake, Imai & Ikeda Law Offices in Tokyo. Recognized as the dean of the Japanese bankruptcy bar, he was recently featured in a Wall Street Journal article because of his work as Trustee of Crown Leasing Company, Japan's biggest case ever with Y1.18 trillion of debt. Mr. Miyake publishes and speaks regularly and, in May, completed his service as chairman of the Insolvency Committee of the Inter-Pacific Bar Association. For several years, he has been co-chair of the International Insolvency Treaty Subcommittee of the International Bar Association.

Selecting Foreign Fellows and involving them productively in College activities provides both challenges and opportunities. As John Barrett's successor to chair the Foreign Fellows nominating committee, I would welcome your suggestions in both respects.

suggesting that serious consideration be given to the implementation of a longterm educational project that was raised and briefly discussed at the March 1998 meeting - namely, organizing and sponsoring the establishment of a Masters Program in Insolvency and Bankruptcy Law at select institutions throughout the nation.

At this time efforts are being made to locate a law school that will be responsive to considering the establishment of a Masters Program and cooperating with the College in formulating a comprehensive curriculum and employment of one or more of our College Fellows for the Masters faculty. A major decision to be made by the College at this time is the funding of such a program and ascertaining the availability of our academic fellows to participate as faculty members for such a program — e.g., in the capacity of visiting professor, outside lecturer, etc. Further details will hopefully be available at the time of our March meeting, and it is hoped that the University of Minnesota Law School may be a willing participant in such a program. Moreover, as the planning moves forward and the concept of a Masters Program becomes more viable, the College may want to form a link with one of our related professional organizations (e.g., American Bankruptcy National Institute, Bankruptcy Conference, Commercial Law League of America, Association of Former Bankruptcy Judges, National Conference of Bankruptcy Judges, American Bar Association, etc.) for the purpose of providing additional funding for the establishment of a truly national program.

The formulation and implementation of a long-range educational project such as the Masters Program will serve as a lasting Monument to the reputation and educational goals of our College will be clearly consistent with the expressed purpose of the College which is "to fund and assist projects that enhance the highest quality of Bankruptcy practice, including undergraduate programs related to Bankruptcy and Insolvency." (Article II, Section 2 of the Bylaws of the American College of Bankruptcy (emphasis added). 📅

The Fall All Fellows Luncheon was held on October 22, 1998, in Dallas, at the Wyndham Anatole Hotel preceding the commencement of the National Conference of Bankruptcy Judges. Chairman Raymond L. Shapiro The luncheon program presided. included an outstanding educational "What Every on presentation Bankruptcy Lawyer Should Know About Taxes." The moderator for the program was Leon S. Forman, the College's Scholar-in-Residence, and the Panel was led by Paul Asofsky, Tax Division, Weil, Gotchal and Manges, Houston, Texas, one of the most knowledgeable lawyers and scholars in this field. Asofsky was ably assisted on the Panel by one of our Fellows, actually a member of the Board, Grant Newton, Professor of Accounting, Pepperdine University, California, an expert in bankruptcy tax law, and by Grover Hartt, III, Assistant Chief, Civil Trial Section, Southwestern Region, Department of Justice, Dallas, Texas, who has had many years experience in dealing with tax matters in bankruptcy and has become one of the federal government's top representatives in this field.

The Panel covered the impact of the automatic stay on tax activity by governmental units, the role of the Internal Revenue Service in bankruptcy cases, establishing tax liability in bankruptcy, the burden of proof in tax matters, and various related questions. The material was well received by an attentive audience, which participated energetically with questions at the end of the session. The College is most appreciative of the substantial contribution to the success of the luncheon on the part of this distinguished Panel.

Currently Cecelia and Michael are working on an "Attorney Case Filing Manual." This will deal with topics from the lawyer perspective, including: review of documents within the firm, formatting, security within the firm, designation of staff, the appropriate functions for attorneys and paralegals in the preparation of documentation, organizing the firm around handling of notices and paper copies, and various other nitty gritty topics that become extremely important for lawyers involved in the prospect of electronic filing.

Under Cecelia's direction are there electronic filings not only for Chapter 11 but now also for Chapter 7 cases being filed in that District.

American College Of Bankruptcy **Board Of Directors Meeting** March 13, 1998 Approved October 22, 1998

A meeting of the Board of Directors of the College was conducted on Friday, March 13, 1998, at the Cosmos Club in Washington D.C.

Those who participated in the meeting included the following: Raymond L. Shapiro, Gerald K. Smith, R. Neal Batson, Myron M. Sheinfeld, David T. Sykes, Bettina M. Whyte, Evelyn H. Biery, Merrill R. Francis, John A. Barrett, Harry D. Dixon, Jr., Stuart E. Hertzberg, David A. Lander, Louis W. Levit, Hon. Ralph R. Mabey, Prof. Grant Newton, Jerome Shulkin, Paul'M. Singer, Hon. Roger M. Whelan, Joel B. Zweibel, Leon S. Forman, William J. Perlstein and Suzanne A. Bingham.

The minutes of the November 19, 1997 meeting of the Board of Directors were approved.

David Sykes reported on the work of the Pro Bono Committee and a questionnaire that was forwarded to College Fellows. The Committee proposed that the College provide funds to organizations that assist in training individuals who provide pro bono services in the consumer bankruptcy area. On motion duly made and seconded, the Board approved the proposal of the Pro Bono Committee. As recommended by the Pro Bono Committee, the College will provide funds to assist bankruptcy pro bono programs designed to educate lawyers, law students, paralegals and other volunteers about consumer bankruptcy. No single grant will exceed \$500, and the total amount of the grants will not exceed \$5,000 over a two-year period. Each grant application will contain information about the pro bono program, its proposed educational program, and the specific uses to which the funding would be dedicated. The pro bono grants will be administered by the Pro Bono Committee and will be subject to the approval of the President of the College. College Fellows will be encouraged to report on programs that are being developed in their districts.

College Counsel William Perlstein reported that, under the Lobbying Disclosure Act, lobbying is defined to cover oral and written communications to covered officials on behalf of a client concerning (a) the formulation, modification or adoption of federal legislation; (b) a federal rule, regulation, or executive order; or (c) any program, policy or position of the United States Government. Testimony presented before Congress or submitted for the public record of a hearing is specifically excluded from the definition of lobbying. Therefore, any activity by College members relating to formal appearances before Congress is outside the scope of the Lobbying Disclosure Act. William Perlstein also reported on additional matters under the Act, such as the requirement for registration if certain amounts of money are expended by the College, a certain number of contacts are made within a certain period of time, or a certain percentage of time is devoted to the contacts.

William Perlstein also reported on the continuing analysis of whether the College should change its state of incorporation to Virginia and indicated that at this time the analysis is incomplete. Virginia has an explicit provision protecting directors for their actions and omissions other than for willful violations of their duties. Nebraska statutes are not so explicit. Simply as a matter of monitoring, it is easier for William Perlstein to monitor the laws of Virginia because of his proximity.

Merrill Francis reported on the admissions procedures and Bylaws provisions pertaining to the selection of College Fellows other than Foreign Fellows and Judicial Fellows. He indicated that the application forms are being revised to require additional detailed information.

Merrill Francis then reported on the admission procedures and Bylaws provisions pertaining to the selection of Foreign Fellows. He indicated that the Board of Regents recommended that there be a separate committee for the Foreign Fellows, with the Foreign Fellows Nominating Committee reporting to the Board of Regents. The Foreign Fellows Nominating Committee could include any Fellow. motion duly made and seconded, the Board authorized a revision of the admissions procedures and Bylaws provisions so that the Foreign Fellows Nominating Committee will be appointed by the Chair of the Board of Regents after consultation with the Chair of the Board of Directors and the President of the College and may include any Fellow. The Board of Directors further authorized College Counsel and the Chair of the Board of Directors to revise the Bylaws in accordance with the resolution,

without further Board approval.

Merrill Francis also reported on the admissions procedures and Bylaws provisions pertaining to the selection of Judicial Fellows. He indicated that there will be a separate committee for Judicial Fellows, with the Judicial Nominating Committee reporting to the Board The Judicial Nominating of Regents. Committee could include any Fellow. On motion duly made and seconded, the Board authorized the revision of the admissions procedures and Bylaws provisions so that the Committee on Judicial Fellows will be appointed by the Chair of the Board of Regents after consultation with the Chair of the Board of Directors and the President of the College and may include any Fellow. No member residing in the district in which a particular judge sits will be allowed to nominate or vote on the nomination of any judicial nominee. As with other nominations, nominations for Judicial Fellows will require a formal and written nomination form. The Board of Directors further authorized College Counsel and the Chair of the Board of Directors to revise the Bylaws in accordance with the resolution, without further Board approval.

Merrill Francis also reported that there is and will be no restrictions on the number of College Fellows. Traditionally, there are no more than forty or fifty total new Fellows every year. There are eleven Foreign Fellows as of this year.

Bettina Whyte reported on the financial situation of the College.

Evelyn Biery reported on the work of the Publications Committee. Because of the cost. the College Columns will be published only twice each year.

Leon Forman reported on the educational program for the October meeting. The program will address tax issues and will be presented by Paul Asofsky and a government attorney.

Mickey Sheinfeld reported on the work of the Focus Groups and the bills being formulated for submission to Congress. Suzanne Bingham reported that a staff member for the Judiciary Committee had contacted the College during the Board of Directors meeting in response to the request of the College for an opportunity to make a presentation before Congress with respect to the proposed legislation. On motion duly made and seconded, the Board of Directors authorized Raymond Shapiro to submit (a) a report to the Fellows on the morning of March 14 and (b) a request that the College determine what role the College would play in the legisla-

In the absence of Joel Piassick, Raymond Shapiro reported on the progress on the College Directory.

Hon. Roger Whelan reported on the College Educational Project, under which the College will assist law schools in presenting courses related to insolvency law. He indicated that he had sent a questionnaire to several Fellows who are professors and that he recommended that there be a committee for the consideration of a possible national L.L.M. program in insolvency law. Jerome Shulkin reported that in December he spent a considerable amount of time with the Dean of the University of Minnesota, who was interested in the program.

Raymond Shapiro reported on electronic filing of pleadings and other papers before the various Bankruptcy Courts.

Jerry Smith reported on the Distinguished Service Award and announced that the recipient for 1998 is Leon Forman. Jerry Smith also reported that the Distinguished Service Award Committee recommended that the College should commend the work of the National Bankruptcy Review Commission through certificates or plaques thanking the members and staff for their contributions to the improvement of the bankruptcy laws of the United States. On motion duly made and seconded the Board authorized the Committee to present the awards to the members and staff and of the National Bankruptcy Review Commission.

Raymond Shapiro reported on the Sponsors and Patrons who made contributions for the 1997-98 fiscal year of the College.

The Board approved the submission of Susan Freeman and Richard Toder to the Fellows as proposed Directors of the College.

Merrill Francis reported that the Board of Regents recommended that Stuart Hirshfield and Sally Schultz Neely be appointed as Regents to fill vacancies. On motion duly made and seconded, the Board appointed Stuart Hirshfield and Sally Schultz Neely as Regents to

had separate fundraising campaigns for each project.

In Memory of Sidney C. Valinn



Sidney C. Volinn, a the United States Bankruptcy Court for the Western District of Washington and a pioneer member of the Bankruptcy Appellate Sidney C. Volinn Appeals for the Ninth

Judge Volinn served the federal counts for 34 years, originally appointed to the bankruptcy bench for the Western District of Washington in 1964 with chambers in Seattle. He later served as chief bankruptcy judge for the Western District and retired as a trial judge in 1993. He was appointed a member of the Ninth Circuit Bankruptcy Appellate Panel in 1981 shortly after that institution was created as a result of Federal legislation enacted in 1978 and soon thereafter became the presiding judge of that until a year prior to his retirement from the appellate panel in January of 1998 as a result of his recall for the purpose of continuing his duties as presiding officer of the

The Court of Appeals for the Ninth Circuit was the only Federal Circuit Court to establish an appellate body designed to two years ago when other Circuit Courts Judge Volinn's leadership and innovations, the Ninth Circuit Bankruptcy Appellate Panel became the model for

Judge Volinn contributed greatly to the success of the Ninth Circuit Bankruptcy Appellate Panel. One of his innovations was to formulate what has become known as the "opt-out"rule. Panel unless the parties involved in the appeal elect otherwise. Until this rule was promulgated, the Ninth Circuit Appellate Panel had been underutilized. The opt-out rule increased the case load of the Bankruptcy Appellate Panel, making it a viable and useful entity, and

As a trial judge, Judge Volinn Western Washington, including the

Judge Volinn was born in 1917 in Boston, Massachusetts. He received his law degree in 1942 from Boston University, where he was elected to the Law Review. He served in the United States Army from 1942 until 1945, when he was discharged with the rank of First Lieutenant. He and his wife Ilse then moved to Seattle where he was to reside for the remainder of his life. His first job with the Office of Price Administration from 1946 to 1948, after which he his appointment in 1964. The name of the firm was Geraghty, Volinn & Lundin.

Active in community affairs, Judge

was an early member of the Board of Directors of R.E.I., serving a term as chairman. He was a member of the Washington State Bar Association, the National Conference of Bankruptcy Judges and the American College of Bankruptcy

A great lover of the outdoors, he with his family were avid hikers and backpackers. In addition to hiking and skiing, he enjoyed bicycling and worked actively for the establishment of bicycle trails in Seattle including the Burke trail. For years he regularly bicycled between his home in downtown Seattle, a distance of approximately eight miles. His good physical condition, in addition to a positive mental outlook, enabled him to make a valiant fight against the cancer that ultimately took his life. Judge Volinn is survived by his wife Ilse, daughter Jane Preuss and son-in-law Rolf Preuss, granddaughter Thea Preuss and grandson Sasha Preuss of Seattle, son Ernest Volinn of Hopkinton, Massachusetts, brother George Volinn of Long Boat Key, Florida, and numerous nieces and nephews. He was preceded in death by a sister, Ruth Schoeniger.

A caring and unselfish man, Judge Volinn possessed an attitude of great concern for the welfare of his fellow human beings. He was a devoted family man and was much loved and admired by his family, his friends and his colleagues. He served as a thoughtful educator and mentor for numerous law clerks and lawyers as well as for his fellow judges. 🚡
